A site investigation was conducted pursuant to ECMC Rule 911 at the CORNELIUS T3N-R65W-S11 L01 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumpline(s) of any separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Ten background soil samples were collected from an area not impacted by oil and gas development and at similar depths and lithologies as confirmation soil samples collected at the location and analyzed for Table 915 metals and soil suitability for reclamation constituents. Background soil sample analytical results were reported with elevated levels of arsenic, barium, chromium (VI), pH, boron, and SAR.

The source will be excavated and confirmation soil samples will be collected and analyzed for the full Table 915-1 suite of analytes. Impacted groundwater was encountered during the site investigation impact delineation see the groundwater monitoring plan below. The proposed excavation is displayed on Figure 2 of Document number 403745826.

Following source removal of soil at the location, monitoring wells will be reinstalled and a no further action (NFA) determination will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915-1 constituents, detailed in the Groundwater Monitoring section, below regulatory limits. As needed, soil and/or groundwater remediation plans will be developed and submitted to ECMC in a supplemental Form 27.

Noble Energy, Inc. proposes to install soil borings that will be improved with temporary PVC monitoring wells. One monitoring well was installed within the source area (if possible) and additional wells will be installed to monitor up-gradient, down-gradient, and cross-gradient groundwater conditions. Each soil boring location will have the soil type logged, will be field screened with a PID, and the interval with the highest PID measurement and/or the interval directly above groundwater will be collected and submitted for analysis of Table 915-1 constituents in soil. Quarterly groundwater monitoring will be completed until four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915 constituents below regulatory limits. Groundwater monitoring wells will be sampled and submitted to a laboratory for analysis of Table 915-1 groundwater constituents: Benzene, Toluene, Ethylbenzene, Total Xylenes (BTEX), naphthalene, 1,2,4-Trimethylbenzene, 1,3,5-Trimethylbenzene, 1-Methylnaphthalene, 2- Methylnaphthalene Chloride ion, Sulfate ion and Total Dissolved Solids (TDS).

OPERATOR COMMENT

Addressing COAs provided 2/20/2025 on approved document number 404023107:

COA 1 Response:

The Operator has proposed a completion of remediation date of 12/31/2026 with consideration of the remedial actions needed to address soil and groundwater impacts. Additional groundwater monitoring wells will be installed 3/24/2025. Assuming four consecutive quarters of groundwater will be achieved within a years time on installation site closure would be requested 3/24/2026. However, excavation of impacted soil, scheduled for Q3 2025, will interrupt consecutive quarters of groundwater monitoring resetting the groundwater monitoring timeline. A minimum of one year of ECMC compliant groundwater monitoring will be needed following reinstallation of groundwater monitoring wells within 45 days of excavation completion.

COA 2 Response:

- The monitoring wells will be installed 3/24/2025.
- If impacts are observed during monitoring well installation a step out monitoring well(s) shall be installed to define the horizontal extent of impacts to soil and groundwater and the monitoring wells shall be installed within 45 days of observations.
- All monitoring wells will be constructed in accordance with the State Engineer's Water Well Construction and Permitting Rules
- Operator will provide boring logs in accordance with standard environmental practices. This includes at a minimum; lithology description, USCS classifications, PID readings, sample collection depths, depth to water, and well construction.
- Operator will submit a minimum of one soil sample for laboratory analysis of the previously approved list of contaminants of concern from each soil boring advanced during monitoring well installation. The sample(s) collected will be from the interval(s) displaying the highest degree of impact or in the absence of apparent impacts from the estimated historic high water table and/or above soil-groundwater interface.

COA 3 Response:

The Operator has updated the Groundwater Monitoring Plan to include analysis of 1-Methylnaphthalene and 2-Methylnaphthalene.
