INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the Boulder 10-41 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Laboratory analytical results indicated a historical release occurred at the decommissioned wellhead. Please refer to the operator comments for additional information regarding the historical release and remedial efforts to be conducted at the wellhead.

Approximately 470' of flowline will be removed, however a portion of the flowline will be abandoned-in-place due to field constraints. The ECMC will be updated in a supplemental Form 27. So as to not disturb the area of field constraint, soil samples will be taken at the start and endpoint of the flowline where the area exists. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected from the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Following source mass removal of hydrocarbon impacted soil, confirmation soil samples will be collected from the final extents of the excavation. Soil samples will be taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

Groundwater was encountered during the initial site investigation. A grab groundwater samples was collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis included BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Visual inspection of the wellhead area occurred during decommissioning activities. Wellhead decommissioning activities and confirmation soil sampling at the Boulter 10-41 wellhead occurred on January 22, 2025. Laboratory analytical results indicated a historical release occurred at the Boulter 10-41 decommissioned wellhead and was reported as a historic release in Form 19 document number 404066505. Hydrocarbon impacted material at the wellhead will be removed and hauled to a permitted disposal facility. Final analytical results will be summarized in a subsequent Supplemental Form 27 submittal and will be reported along with ongoing Remediation Project Number 38435.

Based on the discovery of historic hydrocarbon impacts at the wellhead, source mass removal activities will be initiated as soon as possible. The implementation schedule has been updated to reflect these changes.

OPERATOR COMMENT

This Supplemental Form 27 was prepared for the historic release that was discovered at the Boulter 10-41 wellhead and in connection with the initial Form 19 submitted under Document 404066505.

Groundwater was encountered at approximately 6 ft-bgs during excavation of the wellhead during cut and cap activities. One grab groundwater sample (GW01) was collected and submitted to Origins for analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene, and 1,3,5-trimethylbenzene by EPA Method 8260D, chloride and sulfate anions by IC 300.0 Method and total dissolved solids (TDS) by EPA Method 2540C. All analytical results for the groundwater sample submitted for analysis are compliant with their respective Table 915-1 Screening Levels except for TDS (1720 mg/L), chloride (369 mg/L), and sulfate (691 mg/L). All organics were reported as below their respective Table 915-1 Screening levels.

Supplemental source mass removal activities will be initiated via mechanical excavation as soon as possible.

Due to health and safety concerns, photos were unable to be taken at the time of wellhead decommissioning activities. Photo documentation will be collected during remedial excavation activities.

Flowline decommissioning activities will be conducted by another consultant and will be summarized in a Supplemental Form 27 submittal as available.

Please refer to the attached site investigation assessments and analytics for a detailed description of activities conducted during wellhead decommissioning. A technical review of all analytical data associated with this site has been completed. Pursuant to Rule 913.e, quarterly reporting will continue for the location until data indicates no further action is warranted.
