INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation will be conducted pertaining to the WELLS RANCH AA21-02 wellhead cut and cap and flowline removal. Approximately 1371' of flowline will be removed. The COGCC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The wellhead will be cut and capped per COGCC rules. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

☒ Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. A grab confirmation soil sample will be collected at the wellhead excavation. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Visual inspection of the wellhead and flowline areas will occur during abandonment activities. Field personnel will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling is required. The COGCC Flowline Closure and Wellhead Closure Checklists will be utilized and filled out during the abandonment process. A photolog will be submitted on the Subsequent Form 27.

Two background samples were collected from an area not impacted by oil and gas development at similar depths and lithologies as confirmation samples collected at the location and analyzed for ECOM Table 915-1 metals and soil suitability for reclamation standards (pH, EC, SAR, and Boron). Background concentrations of arsenic and pH exceed the Table 915-1 standards.

Five background samples will be collected from an area not impacted by oil and gas development at similar depths and lithologies as confirmation samples collected at the location and analyzed for ECOM Table 915-1 metals and soil suitability for reclamation standards (SSR) (pH, EC, SAR, and Boron). The samples will be used to characterize native soil and potentially attribute elevated metals and inorganics concentrations to native soil conditions.

Elevated pH and arsenic were observed in multiple locations along the former Wells Ranch AA21-02 flowline. Soil will be resampled and analyzed for Table 915-1 metals at the FLR01 4' sample location and Table 915-1 SSR constituents at the SEP01-FL 4' sample location at the same depth where the initial elevated concentrations were observed in the confirmation samples. Noble will request an NFA be granted if the reanalyzed samples are within the Table 915-1 concentration range.

Alternatively, if the sample's result is outside the Table 915-1 pH concentration range and cannot be attributed to native soil conditions via additional background soil characterization a minimum of five additional samples will be collected to delineate the magnitude and extent of elevated SSR constituents. Following completion of the delineation, Noble will submit a detailed reclamation plan that includes, but is not limited to, soil analysis from adjacent undisturbed lands, revegetation techniques, site stabilization, and details of seeded species. Remedial alternatives will be evaluated if metals concentrations in the recollected samples do not comply with the Table 915-1 standards and cannot be attributed to native soil conditions via additional background soil characterization.

SOURCE REMOVAL SUMMARY

Impacted soil was not discovered during the wellhead cut and cap activities or during removal of the flowlines. Based on site investigation activities and laboratory analytical results of confirmation soil samples collected from the wellhead excavation floors and flowline risers, along the flowlines, and from the separator flowline riser, removal of soil is not needed. The material excavated during cut and cap and flowline removal activities was used as backfill for the excavations.
