On Monday, 03/17/2025, Inspector Kirby Burchett, conducted a follow up field inspection at KT Resources LLC on the WRD Unit 32-12 well, Location #316278, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Colorado Parks and Wildlife (CPW) District with High Priority, NSO, Density, and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

Follow up inspection in response to compliance issues observed during Insp. #702502317 on 1/30/24 and Insp. #702501131 on 4/11/23. The following Corrective Actions are unresolved and original due dates remain:

1. Stormwater BMPs not implemented or maintained.
2. Chemical tank labels illegible or missing.
3. Gas meter calibration out of compliance.
