INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation was conducted pursuant to ECMC Rule 911 at the COLEMAN HERBST T4N-R64W-S22 L01 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Fourteen background samples were collected in native undisturbed soil adjacent to the tank battery at similar depths and lithologies as the samples collected on the tank battery pad. All background samples exceeded the ECMC Table 915-1 RSSLs for arsenic, and the PGSSLs for barium and selenium. One background sample exceeded the PGSSLs for lead. Seven of the 14 background samples exceed the pH soil suitability for reclamation standard.

SOURCE REMOVAL SUMMARY

Describe how source is to be removed.

Impacted soil will be removed from the release area at the Coleman C23-32 (C 22-17 Tank) former tank battery location by excavation. The impacted soil will be disposed of at an approved landfill as non-hazardous waste in accordance with Rules 905 and 906. Copies of the waste manifests will be available upon request.

REMEDICATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Before excavation of impacted soil, soil borings were advanced to delineate the vertical and lateral extent of soil impacts at the location. Confirmation soil samples were collected and analyzed for the full Table 915-1 suite. Groundwater was not encountered between six-and-eight feet below ground surface.

The source will be excavated and confirmation soil samples will be collected and analyzed for the full Table 915-1 suite. The excavation is proposed to measure 105'x130'x10' deep. If groundwater is encountered during the excavation of impacted soil, a groundwater sample(s) will be collected for Table 915-1 organic and inorganic constituents in groundwater (BTEX, 1,2,4 Trimethylbenzene, 1,3,5 Trimethylbenzene, Naphthalene, total dissolved solids, sulfate, and chloride). Should no additional active remediation be required following source removal at the location, a no further action (NFA) determination will be requested within 90 days following laboratory confirmation of the removal of impacted soils with respect to the applicable Table 915-1 screening levels at the site. If groundwater impacts are observed, monitoring wells will be installed following the excavation, and an NFA will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915-1 constituents below regulatory limits. As needed, soil and/or groundwater remediation plans will be developed and submitted to ECMC in a supplemental Form 27.

If necessary following excavation of soil impacts the Operator proposes to install soil borings that will be improved with temporary PVC monitoring wells. One monitoring well will be installed within the source area (if possible) and a minimum of four additional wells will be installed to monitor up-gradient, down-gradient, and cross-gradient groundwater conditions. Each soil boring location will have the soil type logged, will be field screened with a PID, and the interval with the highest PID measurement and/or the interval directly above groundwater will be collected and submitted for analysis of Table 915-1 constituents in soil. Quarterly groundwater monitoring will be completed until four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915 constituents below regulatory limits. Groundwater monitoring wells will be sampled and submitted to a laboratory for analysis of Table 915-1 groundwater constituents: Benzene, Toluene, Ethylbenzene, Total Xylenes (BTEX), naphthalene, 1,2,4-Trimethylbenzene, 1,3,5-Trimethylbenzene, Chloride ion, Sulfate ion and Total Dissolved Solids (TDS).
