A site investigation will be conducted pursuant to COGCC rule 911 at the JULIAS A. PLUSS pit. The pit was historically back-filled. Soil samples will be taken and analyzed per Table 915-1 to ensure that this pit does not require any remediation prior to final reclamation on this location.
