INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the LONG C20-17 flowline removal. Approximately 1582' of flowline was removed. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. So as to not disturb the area of field constraint, soil samples were taken at the start and endpoint of the flowline where the area exists. Soil samples were also taken along the flowline any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were and will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic compounds per ECMC Table 915-1 and inorganic parameters (TDS, chloride, sulfate, sodium, potassium, bicarbonate, and carbonate (as CaCO3)).

Visual inspection of the wellhead and flowline areas occurred and will occur during abandonment activities. Field personnel field screened and will field screen all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was and is required. A detailed summary of decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, is attached to this Form 27.

Four background soil samples were collected near the flowline from one location (BKG01) and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, EC, and boron. Background soil samples were collected from depths ranging between 0.5 and 5 feet below ground surface (ft bgs). Based on the uniform lithology across all soil sample depths and locations across the site, the background results are comparable to all of the soil boring assessment soil sample locations. A secured analytical data report is pending. Upon receipt of a secured report, analytical findings will be summarized and provided on a subsequent Form 27.

On December 3, 2024, approximately 80 cubic yards of impacted material were removed from the flowline locations and disposed of at Buffalo Ridge Waste Management in Keenesburg, CO, under Noble manifests.

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Two remedial excavations were conducted on December 3, 2024 to remove organic impacts observed in decommissioning soil sample locations FL01-01 and FL01-06. Ten confirmation samples were collected from the sidewalls and bases of the final extents of both excavations and analyzed for the full ECMC Table 915-1 suite. A secured analytical data report is pending. Upon receipt of a secured report, analytical findings will be summarized and provided on a subsequent Form 27.
