On Thursday, 03/13/2025, Inspector Kirby Burchett, conducted a follow up field inspection at KT Resources LLC on the WRD Federal 21-33 well, Location #316256, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Colorado Parks and Wildlife (CPW) District with High Priority, NSO, Density, and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

Follow up inspection in response to compliance issues observed during Insp. #702502449 on 3/6/24 and Insp. #702501133 on 4/11/23. The following Corrective Actions are unresolved original due dates remain:

- Gas meter calibration out of date
- Stormwater BMPs not implemented or maintained.

Refer to Inspection Photos for observed compliance issues.

Review of production records indicate well is overdue for a Mechanical Integrity Test.

A follow up on this site inspection will be conducted to ensure all compliance issues have been corrected to comply with ECMC rules.
