Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the LINDSAY C33-10 wellhead cut and cap and flowline abandonment. Approximately 1593' of flowline was abandoned-in-place due to field constraints during the facility decommissioning in 2020, and the ECMC was notified on Form 44 Document Number 403554761.

Previously, one (1) grab soil sample was collected at the wellhead excavation. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.
