## **INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to Rule 911 a site investigation was conducted pertaining to the BRANCH 1-3 wellhead cut and cap. Additional assessment will be completed regarding the flowline removal. Approximately 780' of flowline will be removed. The ECMC will be updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The wellhead was cut and capped per COGCC rules. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

A grab confirmation soil sample was collected at the wellhead excavation. The soil sample was analyzed by a certified laboratory for all ECMC Table 915-1 compounds with the exception of metals. Laboratory analysis indicated that results for VOCs, SVOCs and SSR did not exceed the ECMC regulatory limits at the wellhead location.

Soil samples will be collected during flowline removal at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, where applicable. These soil samples will be analyzed for all soil compounds per ECMC Table 915-1. In addition, one sample will be collected near the former wellhead for analysis of ECMC Table 915-1 metals. Background samples will also be collected from similar lithologic materials for analysis of ECMC Table 915-1 compounds.

**OPERATOR COMMENT**

This Supplemental Form 27 represents the 2Q2022 confirmation soil sample results of the wellhead excavation activities conducted at the Branch 1-3 wellhead, as documented in the denied supplemental form 27 Document #404031875. The confirmation soil sample was collected at the bottom of the excavation on April 1, 2022. All table 915-1 standards for VOCs, SVOCs and SSR were met. The sample was not analyzed for ECMC table 915-1 metals. Based upon these results, further supplemental site investigation activities will be conducted to delineate ECMC metals at the former Branch 1-3 wellhead location.

In addition, flowline sampling will be conducted during Q2 2025. The findings from the sampling event, as well as any additional actions required, will be provided in a subsequent quarterly Supplemental Form 27 submittals.
