**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECOM Rule 911 a site investigation was conducted pertaining to the STROH D07-31 flowline removal. Approximately 923' of flowline was removed; approximately 608' of flowline was abandoned in place and the ECOM was notified on Form 44 Document Number 403628340.

Four (4) grab soil sample were collected at the flowline terminuses at the wellhead and separator (1), flowline directional change (1), and flowline cut-point of abandonment (1). Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including: TPH (total volatile [C6-C10] and extractable [C10 C36] hydrocarbons), organic compounds in soil per ECOM Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECOM laboratory analysis methods.
