INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the VOLKENS 02 wellhead cut and cap. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead.

One (1) grab confirmation soil sample was collected at the wellhead excavation. The soil sample was analyzed by a certified laboratory for all ECMC Table 915-1 compounds with the exception of metals. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods. Laboratory analysis indicated that results for VOCs, SVOCs and SSR did not exceed the ECMC regulatory limits at the wellhead location with the exception of pH. Groundwater was not encountered during the site investigation.

The flowline was previously decommissioned and submitted in a previous Form 27 (doc# 403629133).

OPERATOR COMMENT

This Supplemental Form 27 represents the 1Q2025 timeline update for the VOLKENS 2 wellhead conducted in May 2023. The wellhead sampling was conducted by Eagle Environmental Consulting in May 2023 and identified an exceedance of pH in soil sample WH-FS-01 @ 6'. The soil samples were not analyzed for ECMC Table 915-1 metals, and groundwater was not encountered. A secured analytical data report is attached and data summarized in the attached data package. Based upon these results, further supplemental site investigation activities will be conducted to delineate ECMC metals at the former VOLKENS 2 wellhead location. The findings from the sampling event, as well as any additional actions required, will be provided in a subsequent quarterly Supplemental Form 27 submittals.
