On Wednesday, 03/19/2025, Inspector Kirby Burchett, conducted a follow up field inspection at KT Resources LLC on the Ant Hill Unit Wyatt 25-34 well, Location #316334, in Rio Blanco County, Colorado.

This location is within or in close proximity to a Colorado Parks and Wildlife (CPW) District with High Priority, NSO, Density, and Other Consultation Habitat regulations.

Any Corrective Actions from previous Inspections are still applicable.

Follow up inspection in response to compliance issues observed during Insp. #702502615 on 4/17/24 and Insp. #707800307 on 4/13/23. The following Corrective Actions are unresolved and original due dates remain:

1. Unused equipment storage on location.
2. Gas meter calibration out of compliance.
3. Well is overdue for Mechanical Integrity Test.
