INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the Gemini G Federal 06-33 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Approximately 1169' of flowline was removed. Flowline soil samples were collected along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway. A Flowline Pre-Abandonment Notice (Document number 403878773) is included under Related Forms.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead. Soil samples were taken along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway where applicable. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic and inorganic compounds per ECMC Table 915-1; this sample analysis includes, but is not limited to BTEX, naphthalene, 1,2,4-trimethylbenzene (TMB), and 1,3,5-TMB by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Two background soil samples were collected near the wellhead and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, and EC. The two background samples were collected from a depth of 4 and 5 feet below ground surface (ft bgs). Additionally, five background soil samples (BKG01) were collected from native material adjacent to the tank battery and analyzed for metals in soil per ECMC Table 915-1, pH, SAR, and EC. Arsenic, barium, cadmium, and lead and pH were observed in both background soil samples exceeding ECMC Table 915-1 standards.

A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the barium and lead exceedances observed at sample locations WH01 and FLR01-W. An updated proposed SSI map is attached to this Form 27. Confirmation soil samples will be submitted for laboratory analysis of the CEMC full Table 915-1 suit. Concurrently with the SSI, additional background samples will be collected to determine if barium, and lead exceedances are attributed to native soil conditions at the site. The SSI will be completed in accordance with the proposed implementation schedule and the results of the SSI will be submitted on a subsequent Form 27.

The remaining hydrocarbon impacts identified during decommissioning at soil sampling locations FL01-07 and FL01-08 will be removed via mechanical excavation.

Based on the analytical results collected during initial decommissioning activities, source mass removal activities will be conducted at sample locations FL01-7 and FL01-08 to remove remaining hydrocarbon impacts. Following excavation activities, confirmation soil samples will be collected from the final excavation extents and submitted for laboratory analysis of the full Table 915-1 analytical suite.

A supplemental site investigation (SSI) will be completed to vertically delineate the barium and lead exceedances observed at sample locations WH01 and FLR01-W.

A summary of the field activities will be provided in a subsequent Form 27 following completion of those field activities.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
