INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECOM Rule 911 a site investigation was conducted pertaining to the BLEHM 03 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECOM rules. Approximately 500' of flowline was removed; approximately 170' of flowline was abandoned in place. The Form 44 Doc. Number will be provided on a supplemental Form 27.

Previously, three (3) grab soil samples were collected at the wellhead excavation (1), flowline cut-point of abandonment (1), and flowline terminus at the separator (1). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECOM Table 915-1, EC, SAR, pH, and boron.

Soil samples will be collected along the flowline path at any points of directional change. Soil samples will be analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (C6-C36), organic compounds in soil per ECOM Table 915-1, and EC, SAR, pH, metals, and boron.

All samples collected were/will be analyzed by a certified laboratory using approved ECOM laboratory analysis methods.
