While there, I observed a shut-in facility.                      During this inspection the following possible compliance issues were observed:</p> <ol style="list-style-type: none"> <li>1. It appears to be some erosion south of the tank battery. See attached photo #4, 5.</li> <li>2. It appears to be dead debris on various areas of location. See attached photo #6, 7, 11.</li> <li>3. It appears to be trash on the wellhead fencing. See attached photo #10.</li> <li>4. It appears to be unused equipment inside the separator fencing. See attached photo #12.</li> </ol> <p>A follow up on this site inspection needs to be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
