INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the PARKER 29-34 wellhead cut and cap and flowline removal. Approximately 3075' of flowline was removed. The wellhead was cut and capped per ECMC rules. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. One soil sample was collected and submitted for analysis from the base of the wellhead excavation, and four soil samples were collected and submitted for analysis during flowline abandonment. Additionally, soil samples were field screened at the N-E-S-W sides of the wellhead and at regular intervals along the flowline. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods for ECMC Table 915-1 COCs with the exception of metals. Groundwater was not encountered during the site investigation.

Grab soil samples will collected from the former PARKER 29-34 wellhead location, and at the N-E-S-W sides of the former wellhead. In addition, grab confirmation soil samples will be collected along the former flowline at or near former sample locations FL01@4.0', FL08@4.0', FL09@5.0' and FL15@3.5'. Soil samples will be analyzed by a certified laboratory for ECMC Table 915-1 metals. Background samples will also be collected from similar lithologic materials for analysis of ECMC Table 915-1 compounds.

OPERATOR COMMENT

This Supplemental Form 27 represents the 1Q2025 timeline update for the PARKER 29-34 wellhead cut and cap and flowline abandonment activities conducted in January and April 2023. The wellhead sampling was conducted by Eagle Environmental Consulting in January 2023 and identified no exceedances of ECMC Table 915-1 VOCs, SVOCs or SSR; however, metals were not analyzed. A secured analytical data report is attached in the attached data package.

Based upon these results, further supplemental site investigation activities will be conducted to delineate ECMC metals at the former PARKER 29-34 wellhead and flowline locations. The findings of this assessment, as well as any additional actions required, will be provided in subsequent Supplemental Form 27 submittals.

In April 2023, Fremont Environmental conducted sampling activities along the flowline. Upon receipt of a secured laboratory report, analytical findings will be summarized and provided. Supplemental form 27s will continue to be submitted on a quarterly basis.
