## **INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the HOFFMAN 3-24 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. Approximately 1946' of flowline was removed.

Four (4) grab soil samples were collected at the wellhead excavation (1), flowline terminus at the wellhead (1), and at the bell holes on either side of a waterway (2). One (1) grab soil sample was collected at the flowline terminus at the separator during the facility decommissioning assessment and was reported under Rem. # 27982 (Form 27 Document Number 403668272). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

The delineation data collected in September 2024 including collection of 12 soil samples associated with the HOFFMAN 3-24 flowline is currently being evaluated and recommendations for additional site investigation, if warranted, will be included in a subsequent F27 submittal.
