## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the SCHMIDT 25-07F flowline removal. Approximately 1727' of flowline was removed.

Four (4) grab soil samples were collected at the flowline terminus at the wellhead (1) and along the flowline path (3). One (1) soil sample was collected at the flowline terminus at the separator during the facility decommissioning assessment and was reported under Rem. # 28382 (Form 27 Document Number 403593031). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. One (1) waste characterization sample was collected for ECMC Table 915-1 metals analysis. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Eight (8) grab groundwater samples were collected along the flowline path and analyzed for all organic compounds per ECMC Table 915-1.

No current source was generated. Residual petroleum hydrocarbon impacts along the flowline path will be removed through excavation. Noble proposes an amended Table 915-1 analytical plan to include TPH (C6-C36), ECMC Table 915-1 organics, arsenic, SAR, and pH. Additional backgrounds will be collected from soil of native/similar lithologic material not impacted by oil and gas activity to further compare applicable metals and inorganics, as needed.
