**INITIAL ACTION SUMMARY**

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the HSR-TIM GITTLEIN 6-9 wellhead cut and cap and flowline removal. Approximately 1,020' of flowline was removed. The wellhead was cut and capped per ECMC rules.

One (1) grab soil sample was collected at the wellhead excavation. One (1) grab soil sample was collected at the flowline terminus at the separator during the facility decommissioning assessment and was reported under Rem. # 23982 (Form 27 Document Number 403705332). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Site assessments will be scheduled to collect analytical data. Ten additional soil boring locations will be completed. Samples will be collected along the flowline pathway (4), to confirm sample results at the wellhead (1), and to collect background samples (5). The background samples will be analyzed for Soil suitability (electrical conductivity, sodium adsorption ratio, pH, boron) and Metals per ECMC Table 915-1, while all other samples will be analyzed for the complete ECMC Table 915-1 list. Proposed soil sample locations are included in an attached proposed soil sample location map.
