While there, I observed a shut-in facility. During this inspection the following possible compliance issues were observed: 1. It appears to be equipment left over from PA wellheads. Remove to comply with Rule 603.m., 606. (Corrective Action Date: May 10, 2024) See attached photo #4-7. 2. It appears to be various unused risers near the separator and ECD. Remove or LOTO to comply with Rule 606.
