INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the PROSPECT CO26- 0914 wellhead cut and cap and flowline removal. Approximately 1190' of flowline was removed. The ECMC was updated in a supplemental Form 27 if a portion of the flowline is abandoned-in-place due to field constraints. The wellhead was cut and capped per COGCC rules. Additionally, soil samples were collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number was included under Related Forms.

Grab confirmation soil samples were collected along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods. A grab confirmation soil sample was collected at the wellhead excavation in base of the excavation or the area showing the highest degree of impact during abandonment activities.

Visual inspection along the flowline and at the wellhead and separator areas occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses to determine if laboratory confirmation sampling was required. The applicable ECMC Closure Checklists were utilized and filled out during the abandonment process.

Eleven background samples were collected from an area not impacted by oil and gas development at similar depths and lithologies as confirmation samples collected at the Prospect CO 26-914 flowline location and analyzed for ECMC Table 915-1 metals and soil suitability for reclamation standards (pH, EC, SAR, and Boron). All background samples exceed the Table 915-1 standards for arsenic.

SOURCE REMOVAL SUMMARY

The organic compound exceedances observed at sample location 9FL06@5.0' will be removed through a remedial excavation. Remedial excavation confirmation soil samples will be collected and analyzed for full ECMC Table 915-1 constituents. The impacted soil will be disposed of at an approved landfill as non-hazardous waste in accordance with Rules 905 and 906. Copies of the waste manifests will be available upon request.

REMEDIATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Laboratory analytical results indicated historical releases had occurred at the location of soil sample 9FL06@5.0' was reported as a historic release in Form 19 document number 403498249. A site investigation was completed 10/01/2024. Five soil samples were collected to delineate the horizontal and vertical extent of soil impacts at the location. The proposed excavation extent measures 15' x 20' x 6.0' deep and is illustrated on the attached proposed excavation map. Groundwater was not encountered during decommissioning and site investigation activities.

The source will be excavated and confirmation soil samples will be collected and analyzed for the full Table 915-1 suite of analytes.

If groundwater is encountered during the excavation of impacted soil, a groundwater sample will be collected for Table 915-1 organic and inorganic constituents in groundwater (Benzene, Toluene, Ethylbenzene, Total Xylenes (BTEX), naphthalene, 1,2,4-Trimethylbenzene, 1,3,5-Trimethylbenzene, Chloride ion, Sulfate ion and Total Dissolved Solids (TDS). Should no additional active remediation be required following source removal at the location, a no further action (NFA) determination will be requested within 90 days following laboratory confirmation of the removal of impacted soils with respect to the applicable Table 915-1 screening levels at the site.

If groundwater impacts are observed, an NFA will be requested once four consecutive quarters of groundwater sampling have been completed and reported at the location with concentrations of Table 915-1 constituents below regulatory limits. As needed, soil and/or groundwater remediation plans will be developed and submitted to ECMC in a supplemental Form 27.

The implementation schedule has been changed due to the decommissioning of the Prospect CO 26-0914 flowline and necessity for source mass removal adjacent to the flowline. The proposed excavation will be completed following the approval of this form.

OPERATOR COMMENT

This Form 27 is being submitted to address the historic reportable release discovered at the former Prospect CO 26-0914 flowline location. A proposal to excavate the 1,2,4-trimethylbenze (TMB), 1,3,5-TMB, and total volatile [C6-C10] and extractable [C10-C36] hydrocarbons (TPH) exceedances identified during decommissioning at sample location 9FL06@5.0' is presented in the Remedial Action Plan section of this Form 27. This release was reported under Form 19 document # 403498249.

The organic compound exceedances observed at sample locations 9FL06@5.0' will be removed through remedial excavation activities. Remedial excavation confirmation soil samples will be collected and analyzed for full ECMC Table 915-1 constituents. The proposed excavation extent is illustrated on the attached proposed excavation map.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the proposed supplemental source mass removal will be submitted on a subsequent Form 27.
