INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the UPRR 39 PAN AM G 1 wellhead cut and cap and flowline removal. Approximately 1250' of flowline was removed. Approximately 60' of flowline was abandoned-in-place due to field constraints. The wellhead was cut and capped per ECMC rules.

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. A grab confirmation soil sample was collected at the wellhead excavation. Two (2) grab soil samples were collected from the cut points adjacent to the portion of flowline abandoned in place. One (1) additional grab soil sample was collected at the flowline terminus. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. One (1) soil sample was collected for waste characterization of ECMC Table 915-1 metals. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Residual petroleum hydrocarbon impacts identified at the site were removed through excavation. Soil samples were collected for analysis of TPH C6-36, Table 915-1 organics in soil, and selenium per supplemental Form 27 #403182236. Soil samples were collected to confirm the vertical and lateral extents of the impacts following source removal.

Results of the excavation/confirmation sampling indicate that all current organic concentrations at the flowline terminus are in compliance with ECMC Table 915-1 regulatory limits.

Additional soil samples were collected to address exceedances at FL-SS-10 and FL-SS-11 on 2/13/2025. Analytical results are pending laboratory analysis and will be reported in a supplemental Form 27. NFA will be considered when soil concentrations are in compliance with ECMC Table 915-1 standards.

OPERATOR COMMENT

This is a quarterly update. Additional soil samples were collected to address exceedances at FL-SS-10 and FL-SS-11 on 2/13/2025. Analytical results are pending laboratory analysis and will be reported in a supplemental Form 27.

In response to ECMC Form 27 COA with approval dated 12/24/2024 (Document Number 403927322), Operator is submitting a replacement Form 27. Based on currently available data, this project is not affected by data integrity irregularities and is not associated with Operator's data integrity review process and its Rule 525.e. Voluntary Disclosure. As part of its data integrity review process, Operator requested the lab protect the laboratory analytical reports from subsequent unauthorized modification by anyone outside the lab, which resulted in the lab reissuing the original reports with additional protections (Y204247, Y205462, Y206632, and Y303469). The Reissued Reports were received directly from the lab on 2/13/2025 which includes a watermark confirming both the laboratory representative who reissued the report and the date and time of the reissuance. The metadata associated with these Reissued Reports also includes the lab representative's name, the date and time the laboratory reissued the report, and an explanation for the report reissuance. The Reissued Reports are attached to this submission.

In the event additional responsive information is received or discovered that would suggest this project should be incorporated into the ongoing data integrity review process associated with Operator's Rule 525.e. Voluntary Disclosure, Operator will update and/or amend the statements in this submission and provide any new or revised data or other information responsive to ECMC's general comments responding to Operator's Form 27 submission found in Document Number 403927322.
