## INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the LDS WHITE D17-08 wellhead cut and cap and flowline removal. Approximately 2040' of flowline was removed. The wellhead was cut and capped per ECMC rules.

Two (2) grab soil samples were collected at the wellhead excavation (1) and flowline terminus at the separator (1). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

In September 2024, delineation sampling for residual EC was conducted at the LDS White #D17-18 wellhead site, with four wellhead delineation soil borings advanced (WH-01-N, WH-01-S, WH-01-E, and WH-01-W) to delineate EC exceedance from sample, WH-FS-01@6'. Additionally, four background soil borings (BG-01 through BG-04) were advanced to evaluate EC from non-impacted areas of the site.
