Comment: It appears that reclamation was conducted on the location and access road. Desirable vegetation appears to be progressing towards 80% on portions of the location. There are large patches of undesirable weeds with lower desirable vegetation coverage, particularly a patch to the south of the wellbore. This patch consists primarily of Cheatgrass, a list C noxious weed and Kochia, an undesirable weed. See attached pictures.

Corrective Action:	Control noxious weeds on location. Conduct additional reclamation activity according to Rule 1004 to establish vegetation on the entire disturbance area with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.					Date _____
