A site investigation was conducted pursuant to ECMC Rule 911 at the HOWARD USX T6N-R64W-S9 L02 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumpline(s) of any separator(s). Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Nine background soil samples were collected from an area not impacted by oil and gas development and at similar depths and lithologies as confirmation soil samples collected at the location and analyzed for Table 915-1 metals and SSR constituents. Background soil sample analytical results were reported with elevated levels of pH, Arsenic (As), Barium (Ba), Cadmium (Ca), Lead (Pb) and Selenium (Se).

Soil will be re-sampled and analyzed for the full Table 915-1 analyte suite at the AST01@0.5', AST02@0.5', AST03@0.5', AST04@0.5', PWV-E@2', PWV-E2@2', PWV-N@2', PWV-S@2', PWV-W@2', PWV-W2@2', SEP01-DL@2', SEP02-DL@2' and PWV-B@5' sample locations at the same depth where the initial confirmation samples were collected in order to confirm initial analytical results. Additional local background samples will also be collected to further characterize native soil conditions. Noble will request an NFA be granted if the reanalyzed samples comply with the Table 915-1 concentration standard. Background samples will be used to justify elevated concentrations.

Elevated pH was observed in two discrete locations at the former Howard USX A09-19 Tank Battery. Soil will be re-sampled and analyzed for the full Table 915-1 analyte suite at the FL05@2' and FL06@2' (Separator Flowline Riser Tie-in) sample locations at the same depth where the initial elevated pH concentrations were observed. Noble will request an NFA be granted if the reanalyzed samples comply with the Table 915-1 concentration standard. Background samples will be used to justify elevated concentrations.

Alternatively, if the sample results exceed the Table 915-1 standards and cannot be attributed to native soil conditions via background soil characterization a minimum of five additional samples will be collected to delineate the magnitude and extent of elevated constituents.

The implementation schedule has been changed due to the necessity for supplemental site investigation activities adjacent to the former Howard USX A09-19 tank battery. The proposed site investigation will be completed following the approval of this form.

OPERATOR COMMENT

This Form 27 is being submitted for the former Howard USX A09-19 tank battery location to include decommissioning results and propose a supplemental site investigation

The operator will conduct a supplemental site investigation by collecting re-samples at the previously submitted confirmation sample locations that were out of temperature preservation range. These locations include: AST01@0.5', AST02@0.5', AST03@0.5', AST04@0.5', PWV-E@2', PWV-E2@2', PWV-N@2', PWV-S@2', PWV-W@2', PWV-W2@2', SEP01-DL@2', SEP02-DL@2', and PWV-B@5', in order to confirm the initial analytical results. Additionally, the operator will collect re-samples at FL05@2' and FL06@2' (Separator Flowline Riser Tie-in) to confirm the presence or absence of elevated pH concentrations. Further, local background samples will be collected to help characterize the native soil conditions. Please refer to the site investigation as outlined in this proposed Site Investigation Report workplan and the attached proposed Site Investigation Plan for sample locations. The Operator will complete the additional site investigation activities as outlined in the proposed Site Investigation Report workplan following the approval of this form.

Based on currently available data, this project is not affected by data integrity irregularities and is not associated with Operator's data integrity review process and its Rule 525.e. Voluntary Disclosure. As part of its data integrity review process, the operator requested Summit Scientific protect the laboratory analytical reports from subsequent unauthorized modification by anyone outside the lab, which resulted in the lab reissuing the original reports with additional protections (Reissued Reports). The Reissued Reports were received directly from the lab on March 31, 2025 and April 7, 2025. The Document Properties for the Reissued Reports were updated to indicate that it was locked and reissued. Security Settings were assigned, and a Digital ID / Verified Certification was applied to the Reissued Reports. The Digital ID associated with the Reissued reports includes metadata detailing the laboratory representative's name, the date and time the laboratory reissued the report, and an explanation for the report reissuance. The Reissued Reports are attached to this submission.

In the event additional responsive information is received or discovered that would suggest this project should be incorporated into the ongoing data integrity review process associated with Operator's Rule 525.e. Voluntary Disclosure, Operator will update and/or amend the statements in this submission and provide any new or revised data or other information."

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
