This location is within or in close proximity to a Colorado Parks and Wildlife (CPW) District with High Priority, NSO, Density and Other Consultation Habitat regulations.

Follow up inspection in response to compliance issues observed during Insp. #702502613 on 4/17/24. The following compliance issue unresolved and original due date remains:

1. Gas meter calibration out of compliance.
