INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the QC A32-19 wellhead cut and cap and flowline abandonment. Approximately 1,675' of flowline will be removed. The wellhead will be cut and capped per ECMC rules.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Two grab soil samples were collected at the base of the wellhead excavation (1) and at the flowline terminus (1). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Samples will be collected at all flowline change of directions and will be provided on a supplemental Form 27.

Proposed Groundwater Sampling

If groundwater is encountered during the site investigation a grab groundwater will be collected and analyzed for all organic compounds per ECMC Table 915-1.

Visual inspection of the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using a PID, visual, and olfactory senses to determine if laboratory confirmation sampling was required. The ECMC Tank Battery and Produced Water Vessel Closure Checklists were utilized and filled out during the abandonment process.

The samples will be analyzed for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, boron, and ECMC Table 915-1 metals by a certified laboratory.

SOURCE REMOVAL SUMMARY

No impacted soil was discovered during the QC USX A 32-19 wellhead cut and cap activities or during removal of the flowlines. Based on site investigation activities and laboratory analytical results of confirmation soil samples collected from the wellhead excavation floors and flowline risers, along the flowlines, and from the separator flowline riser, removal of soil is not needed. The material excavated during cut and cap and flowline removal activities was used as backfill for the excavations.
