Extent has not been determined although impacts appear to be minimal or non-existent based on initial field screenings. Above measurements are estimates based on the setting of the release, the depth of the flowline, the soil type, operator knowledge of the area, and the estimated spill volume of 1.89 bbls, which was gathered from SCADA data, operational parameters, and well trending. Soils at the point of release (POR) excavation were field screened on 4/17/2025 and exhibited PID reading ranging from background to 88.8 ppm at the point of release. The sample from the POR with the highest PID reading (20250417-P27 595-(POR)@5.5) was submitted for analysis of ECMC Table 915-1 full list. On April 9, 2025, the operator identified a leak in the P27-595 (16C-27) flowline through well trending. Pressure testing confirmed the release was near the wellhead and the well was promptly shut-in. The point of release was determined to be corrosion of the below ground 90° fitting at the 1st 90 from the wellhead.

Describe measures taken to prevent the problem(s) from reoccurring:

The damaged portion of the flowline had been replaced. Preparations are being made to replace all flowlines onsite.
