Approximately 60' of flowline was abandoned-in-place due to field constraints. The wellhead was cut and capped per ECMC rules.

Residual petroleum hydrocarbon impacts identified at the site were removed through excavation. Soil samples were collected for analysis of TPH C6-36, Table 915-1 organics in soil, and selenium per supplemental Form 27 #403182236. Soil samples were collected to confirm the vertical and lateral extents of the impacts following source removal. Results of the excavation/confirmation sampling indicate that all current organic concentrations at the flowline terminus are in compliance with ECMC Table 915-1 regulatory limits. Further evaluation of residual pH along the flowline path appears warranted at this time.

REMEDICATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Results of the excavation/confirmation sampling indicate that all current organic concentrations at the flowline terminus are in compliance with ECMC Table 915-1 regulatory limits. Verification soil samples will be collected to confirm the pH values near FL-SS-10 and FL-SS-11. Elevated pH levels will be delineated and further remediation will be proposed on a supplemental Form 27 as needed. NFA will be considered when soil concentrations are in compliance with ECMC Table 915-1 standards.
