### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Following the removal of the partially buried vault (PBV) [Serial Number 4647] at the PUCKETT-66S97W 25SENE (Facility ID: 335112) (Mesa 8) four sidewalls and one base confirmation soil sample were collected from the excavation footprint on September 12, 2024. A minimum of six inches of soil was scrapped back from each sampling surface prior to sample collection to assure representative samples were collected. All confirmation samples were collected from areas exhibiting the greatest degree or potential impact based on field observation. Soils removed to access the PBV location were stockpiled along the eastern edge of the trench excavation (STOCK1). Additionally, the transfer flowline located between the former PBV and separator skid was trenched to remove associated PBV infrastructure and the removed soils were stockpiled (STOCK02). One 5-point aliquot composite soil sample was collected from each of the associated stockpile locations. The headspace of each soil samples was field screened using a photo-ionization detector (PID) to detect for the presence or absence of volatile organic compounds (VOCs). Soils were also field characterized by a geologist for hydrocarbon odors or staining via visual and olfactory sense. A total of seven confirmation soil samples were submitted to Pace Analytical for laboratory analysis of ECMC Table 915-1 constituents.

Following the removal of the partially buried vault, four sidewall soil samples and one base soil sample will be collected from the open excavation remaining following the removal and submitted for laboratory analysis of all Table 915-1 constituents. For comparison to background soil conditions, up to four soil samples may be collected from nearby, undisturbed native areas and submitted for analysis of Electrical Conductivity (EC), Sodium Adsorption Ratio (SAR), pH, Boron, and metal constituents listed in ECMC Table 915-1.
