INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On August 8, 2023, initial sampling was conducted to characterize the excavation following the removal of the PBV. One soil sample was collected from the base of the excavation at 8 feet below ground surface (bgs) and four samples were collected from the sidewalls of the excavation at 4 to 5 feet bgs. Analytical results indicated compliance with Table 915-1 Residential Soil Screening Levels (RSSLs) except for pH, arsenic, and hexavalent chromium (CrVI).

On April 16, 2024, an Initial Form 27 was submitted to the Energy & Carbon Management Commission (ECMC) via Document 403721015 to open Remediation Project 35092 and report results of the initial investigation. Initial notification was not submitted to the ECMC prior to PBV removal due to a miscommunication between QB departments regarding which locations were planned for PBV decommissioning. The form and a reduced analyte suite of arsenic and hexavalent chromium were approved on April 22, 2024. See Form 27 Document 403721015 and the associated Report of Work Completed (ROWC) for details.
