INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On December 10, 2022 the operator discovered a line leaking at approximately 1:06 pm. The line was shut in and the spill contained by 1:30 pm. Standing liquids were removed by vac truck and the spill path was water washed. The cause of the spill was determined to be the failure of a 3 inch fiberglass line at a depth of approximately 4 feet bgs.

PROPOSED SAMPLING PLAN

Preliminary soil samples were collected from beneath the repaired flowline (FEE 40 (ORIGIN)) on December 20, 2022 and from the spill path (FEE 40-SS1 through FEE 40-SS4) on July 11, 2023. A total of seven (7) grab samples including two (2) background samples analyzed for Table 915-1 parameters were collected at depths ranging from 0 to 7 feet below ground surface. Results indicate elevated SAR, EC and pH within the impacted area.

OPERATOR COMMENT

This form serves as an update to sampling activities for REM #35088 since the submittal of the Initial Form 27 (Doc #403612724).

The spill was allowed to naturally attenuate. FEE 40-SS4 was sampled on April 8, 2025 and analyzed for SAR, EC and Hot Water Soluble Boron. Two additional background samples were collected. Results indicate continued exceedances to Table 915-1 standards above local background levels of SAR and EC at SS4. Please see the attached documents for sample locations, depths and analytical results.

A sample (FEE 40) was collected on December 12, 2022 from beneath the damaged line at the spill origin. This sample is within background levels from the selected nearby past releases for all Table 915-1 parameters.

Natural attenuation will continue to be monitored at this remediation. Scout requests approval of a reduced analyte list on all future samples at SS4 consisting of SAR and EC only. An annual reporting schedule is requested for this project moving forward.

A Form 19 Closure Request has been submitted for Spill #483437 (Doc #404173837).
