INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation was conducted pertaining to the SATER USX CC19-10 wellhead cut and cap and flowline removal. The wellhead was cut and capped per ECMC rules. Approximately 1101' of flowline was removed (Form 44 document # 403537200 in process). Flowline closure data will be included on a Supplemental Form 27.

One (1) grab soil sample was collected at the wellhead excavation. One (1) grab soil sample was collected at the flowline terminus at the separator during the facility decommissioning assessment and was reported under Rem. # 26899 (Form 27 Document Number 403498915). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods. Flowline closure data will be discussed on a Supplemental Form 27.

OPERATOR COMMENT

In response to ECMC Form 27 Comment dated 02/06/2025 (Document Number 403928812), Operator is submitting a replacement Form 27. Based on currently available data, this project is not affected by data integrity irregularities and is not associated with Operator's data integrity review process and its Rule 525.e. Voluntary Disclosure. As part of its data integrity review process, Operator requested the lab protect the laboratory analytical report from subsequent unauthorized modification by anyone outside the lab, which resulted in the lab reissuing the original report with additional protections (Y304042 Noble-Sater USX CC #19-10.pdf). The Reissued Report was received directly from the lab on 13 February 2025 which includes a watermark confirming both the laboratory representative who reissued the report and the date and time of the reissuance. The metadata associated with this Reissued Report also includes the lab representative's name, the date and time the laboratory reissued the report, and an explanation for the report reissuance. The Reissued Report is attached to this submission.

Operator recommends flowline confirmation soil samples to be collected at least every 250 feet along the flowline as shown on the attached proposed sampling figure. Samples will be analyzed for all ECMC Table 915-1 analytes. Background soil samples will be collected and analyzed for ECMC Table 915-1 SSR parameters and metals. Results will be provided and addressed on a supplemental Form 27 when obtained.

In the event additional responsive information is received or discovered that would suggest this project should be incorporated into the ongoing data integrity review process associated with Operator's Rule 525.e. Voluntary Disclosure, Operator will update and/or amend the statements in this submission and provide any new or revised data or other information responsive to ECMC's general comments responding to Operator's Form 27 submission found in Document Number 403928812.
