A site investigation was conducted pursuant to ECMC Rule 911 at the TIMMERMAN WERTZ T4N-R65W-S13 L01 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation (FS01@5', SS01@2.5' - SS04@2.5'), beneath the ground oil tank(s) (AST01@0.5'), and at the risers for the flowline(s) (SEP01-FL@4') and dumpline(s) (SEP01-DL@4') of any separator(s) during decommissioning. Approximate soil sample coordinates for AST01@0.5' were not collected due to a field data collection error, the sample location has been estimated using 2020 Google Earth Imagery. An updated version of Table 1 - Soil Sample Locations is attached to this Supplemental Form 27.

Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

This Form 27 is being submitted as a 1Q25 Timeline Update for the former Timmerman 23-13 Tank Battery. A proposal to delineate the pH exceedance observed at sample location AST01 @0.5' during decommissioning is presented in the Site Investigation Report section of this Form 27.

The former Timmeman 23-13 Tank Battery was decommissioned on 8/25/2023, and results are included on Form 27 Document #403573510.

Concurrently with the SSI, additional background samples will be collected to determine if pH, arsenic, barium, and cadmium are attributed to native soil conditions at the site.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The results of the supplemental site investigation will be submitted on a subsequent Form 27.
