Inspection #696206100 observed that the Location and access road have not been decompacted, recontoured, regraded and reclaimed in accordance with Rule 1004.a. Inspection required Operator to comply with 1004 Rules by 11/15/2024.

It was observed in this inspection that reclamation of the Location and the access road has not been performed in accordance with 1004 Requirements.

Operator submitted Docket No. 240200035 requesting a variance to 1004 Rules, to not reclaim the Location and access road.

The overall status of the Reclamation is being considered "in process" pending resolution of the Variance Hearing Application.
