A site investigation was conducted pursuant to ECMC Rule 911 at the EASTON T4N-R65W-S12 L02 Facility and Tank Battery location.

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the risers for the flowline(s) and dumpline(s) of any separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Fifteen background samples were collected from an area not impacted by oil and gas development at similar depths and lithologies as confirmation samples collected at the Easton location and analyzed for ECMC Table 915-1 metals and soil suitability for reclamation standards (pH, EC, SAR, and Boron). Two samples exceeded the 915-1 standards for SAR, all samples exceeded the 915-1 standards for As, one sample exceeded 915-1 for Ba and one sample exceed the 915-1 standard for Pb.

SOURCE REMOVAL SUMMARY

Impacted soil was removed from the release area at the Easton tank battery location by excavation. The impacted soil was disposed of at an approved landfill as non-hazardous waste in accordance with Rules 905 and 906. Copies of the waste manifests are available upon request.

REMEDICATION SUMMARY

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Provide a brief narrative description including: technical justification, schedule for implementation, estimated time to attain NFA status, plus plans and specifications for the selected remedial action technology.

Impacted soil was removed from the Easton location by excavation. This was confirmed by analysis of soil samples collected from the exterior sidewalls and the floor, which were below the ECOM Table 915-1 PGSSLs for organic petroleum constituents upon completion of the excavation. Groundwater, collected from the floor of the excavation, also achieved the ECOM Table 915-1 standards. Approximately 235 cubic yards of impacted soil were removed and transported to the landfill. The soil data are illustrated and summarized in the attached tables and figures.

The Operator proposes to resample and analyze for Table 915-1 metals at sample locations B1@7', B2@7' SW1@2', W1@2', W2@2', E1@2', N1@2', N2@2', NW1@2', SW1@2', and E2@2' to verify the presence of metals concentrations greater than the natural variability observed in the location's background soil samples. Noble proposes resample and analyze Table 915-1 SSR constituents at sample locations NW1@2', W1@2', S1@2', and SE1@2'. The Operator will request a no further action designation be granted if the reanalyzed samples comply with their respective Table 915-1 concentration standards. If the reanalyzed samples exceed the Table 915-1 concentration standards the Operator will evaluate remedial options to address elevated concentrations of metals and/or SSR constituents remaining in situ.

GROUNDWATER MONITORING

A groundwater sample (GW01) was collected from the floor of the excavation at a depth of five feet, and submitted to Summit Scientific, Inc. in Golden, Colorado for the analyses of organic petroleum constituents benzene, toluene, ethylbenzene, xylenes (BTEX), 1,2,4-trimethylbenzene; 1,3,5-trimethylbenzene and naphthalene by EPA Method 8260B.

The laboratory analysis indicated that the groundwater sample achieved the ECOM Table 915-1 organic standards. The groundwater chemistry is shown on Figure 6 and the analytical data are summarized in Table 6.
