INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

This oil and gas Location is in the Colorado ECMC Orphaned Well Program ("OWP"). This Form 27 Initial presents the site investigation activities to be performed during decommissioning of Oil and Gas Facilities, specifically sampling activities for cut and cap following emergency plugging and abandonment (PA) of the well. Field screening will be performed of the four sidewalls and floor of the wellhead excavation to investigate for evidence of E&P Waste impacts. At a minimum, soil samples will be submitted to an accredited environmental laboratory for analysis of Table 915-1 parameters from the excavation sidewall soils that exhibit E&P Waste impact; or from the expected downgradient sidewall in the absence of E&P Waste impact; and from the base of the excavation. Soil samples will be collected and analyzed in accordance with Colorado ECMC 900 Series Rules.

Grab soil samples will be collected from areas most likely to exhibit E&P Waste impacts. Soil samples will be submitted for analysis of Table 915-1 parameters including organic compounds (TPH ranges C6-C36; BTEX; 1,2,4-Trimethylbenzene, 1,3,5-Trimethylbenzene, Naphthalene, PAH) and inorganic compounds (metals, soil suitability for reclamation).

Groundwater samples are not expected to be collected as part of this investigation. OPERATOR COMMENT

The former OMIMEX PETROLEUM INC - 66190 BLEDSOE #7-6-5-44 (OWP) gas well (API #05-125-09486) BLEDSOE-65N44W 6SWNE (Location ID #336843) is in the ECMC Orphaned Well Program ("OWP"). This Form 27 Initial presents the site investigation and remediation workplan for cut and cap sampling following emergency plugging and abandonment (PA) of the well. A section of tubing was observed sticking up from the well. Flowlines and other oil and gas facilities will be decommissioned during a future OWP project under a separate scope of work. The Location lies within CPW mapped high priority habitat (HPH) for a Greater Prairie Chicken Production Area. At least 5 days after PA to allow for monitoring of successful plugging, the soils from the four excavation sidewalls and floor will be observed and field screened for evidence of E&P Waste impacts. At a minimum, soil samples collected from the sidewall exhibiting the highest degree of E&P Waste impacts, or the expected downgradient sidewall in the absence of impacts, and the excavation floor sample will be submitted to an accredited environmental laboratory for analysis of full Table 915-1 parameters. A Form 27 Supplemental will be submitted within 90 days from the date results are received. A stand alone laboratory secured analytical report and wellhead decommissioning package will be attached to the Form 27 Supplemental.
