INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to Energy & Carbon Management Commission (ECMC) Rule 911, a site investigation was conducted pertaining to the Aurora USX AB25-25 wellhead cut and cap. On August 16, 2021, initial wellhead characterization sampling was completed following cut and cap operations. Samples were field screened from all four walls and the base of the wellhead excavation as well as four surface locations to the N-E-S-W of the excavation. Two samples were collected from the base of the excavation and submitted for analysis of ECMC Table 915-1 organic constituents of concern and Soil Suitability for Reclamation (SSR) constituents. One background sample was collected and analyzed for sodium adsorption ratio (SAR) and electrical conductivity (EC). See Form 27 Document 402894137 and the associated Site Investigation Report (Document 402894177) for details.

The flowline was previously abandoned on April 10, 2018, and the ECMC was notified on Form 44 Document 402263524.

Samples were field screening from all four walls and the base of the wellhead excavation as well as four surface locations to the N-E-S-W of the excavation. Two samples were collected from the base of the excavation and submitted for analysis of Table 915-1 organic constituents of concern and SSR constituents; analytical results indicated values of EC and SAR elevated above allowable limits. One background sample was collected and analyzed for SAR and EC; analytical results were compliant with SSR standards.
