INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to ECMC Rule 911 a site investigation will be conducted pertaining to the SPIKE STATE CC30-21 wellhead cut and cap and flowline removal. Approximately 1037' of flowline was removed. The wellhead will be cut and capped per ECMC rules. Additionally, soil samples will be collected at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. The Flowline Pre-Abandonment Notice Document number is included under Related Forms.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Additionally, soil samples were collected along the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway, AS APPLICABLE to abandonment type. A grab confirmation soil sample was collected at the wellhead excavation. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Per the COA issued by the ECMC via document number 403904630, the previously field screened locations FL01 (3'), FL02 (3'), FL03 (4'), and the wellhead flowline riser tie in will be resampled. The soil samples collected adjacent to the flowline will be submitted for laboratory analysis for Full Table 915-1 Contaminants of Concern. Additionally, background soil samples will be collected to characterize native soil conditions at the site. Background soil samples will be analyzed by a certified laboratory for analysis of metals per ECMC Table 915-1 and soil suitability for reclamation parameters including pH, EC, SAR, and boron. The proposed flowline and background sample locations are included in the attached Site Map of document number 404023016. The proposed sampling will be completed in accordance with the proposed implementation schedule, and the results of the additional investigative actions will be submitted on a subsequent Form 27.

Impacted soil was not discovered during removal of the flowlines. Based on site investigation activities and laboratory analytical results of confirmation soil samples collected from the flowline risers, along the flowlines, and from the separator flowline riser, removal of soil is not needed. The material excavated during flowline removal activities was used as backfill for the excavations.

Pending ECMC EPS form review/approval, the Operator will complete the additional site investigation and remediation as outlined on Doc. # 404023016 and this F27. Supplemental Form 27s will be prepared and submitted on a quarterly schedule to provide updates and progress of the remediation until closure criteria has been achieved.

Decommissioning activities at the Spike State CC30-21 revealed a different flowline path other than depicted on the initial approved soil sample location map.

Per the COA issued by the ECMC via document number 403904630, the operator will go back and resample the flowline at any points of material change and/or hammer unions, directional changes, as well as at the bell holes on either side of a waterway as applicable to the actual flowline path, and additionally collect background samples. Please refer to the site investigation as outlined in this proposed Site Investigation Report workplan and the attached proposed confirmation and background soil sample location map (Figures 2 & 3) for sample locations on document number 404023016. Noble will request an NFA be granted if the analyzed samples comply with the Table 915-1 concentration standard. Background soil samples will be collected to characterize native soil conditions at the site.
