Comment: The access road is mostly bare of vegetation and needs to be reseeded. It appears remediation was completed however, open excavations have not been backfilled and reclaimed. The location consists mostly of annual weeds which will need to be controlled. Additional seeding will need to be performed at the location to promote perennial vegetation establishment. Continue to monitor and maintain the location until the final reclamation requirements are achieved.
