INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A site investigation was conducted on 10/10/24 pursuant to ECMC Rule 911 at the Vega USX A03-05 tank battery. Discrete soil samples were collected for laboratory analysis in the sample locations in the Initial Form 27 sampling plan. Grab confirmation soil samples were collected from the produced water vessel excavation (PWV01-N@3', PWV01-B@6'), beneath the above-ground storage tank (AST01@0-6"), and at the dump lines of any separators (SEP01-DL@4'). Additional grab soil samples collected from beneath the produced water vessel excavation (PWV01-E@3', PWV01-S@3', PWV01-W@3') were placed on-hold. On-site dump lines located between the separator and tank battery were removed by pulling from either end. Field screening samples were collected beneath the water dump line (WDL01@0-6"), meter houses (GS01@0-6", GS02@0-6"), compressor (GS03@0-6"), and emission control device (GS04@0-6"). All sampling was conducted in accordance with the Initial Form 27 Document No. 403547130. Grab confirmation soil samples collected beneath the flowline risers were collected for laboratory analysis and will be submitted on Form 27s under the Ruff 22-3 flowline (Remediation Project # 32423) and the Ruff 21-3 flowline (Remediation Project # 32425).

All sampling was conducted in accordance with the Initial Action Summary. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

If groundwater is encountered during site investigation activities, a grab sample will be collected. If contaminated soil is in contact with groundwater or if free product/hydrocarbon sheen are observed, the release will be reported in accordance with Rule 912.b. Groundwater samples will be submitted for laboratory analysis of BTEX, naphthalene, 1,2,4-trimethylbenzene and 1,3,5-trimethylbenzene by EPA Method 8260, chloride and sulfate anions by EPA Method 300.0, and total dissolved solids (TDS) by Method SM 2540C.

Additional Investigative Actions

Additional alternative investigative actions described in attached Site Investigation Plan (summary):

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses. Additionally, discrete soil samples were collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. A detailed summary of decommissioning activities, including field notes, site photos, figures, and laboratory analytical results, were attached to a previous Form 27 Document No. 403965948.

Additional background sampling will be conducted in conjunction with the remedial excavation proposed in the Site Investigation Report section of this Form 27. The organic exceedance in sample location PWV01-B@6' will be removed through remedial excavation. Soil samples will be collected and analyzed for the full ECMC Table 915-1 list of contaminants.

The 1-methylnaphthalene exceedance observed at sample location PWV01-B@6' will be removed through remedial excavation. The results of the remedial excavation will be submitted on a subsequent Form 27.

In addition to the remedial excavation described in the Source Removal Summary, background soil samples will be collected to determine if pH and arsenic are attributed to native soil conditions at the site. PDC requests to submit future soil samples for full analysis of the Table 915-1 analytical suite. If soil that is more heavily impacted with hydrocarbon compounds (based on PID readings, visual and/or olfactory indicators) is discovered during the remedial excavation, a soil sample will be collected from that location and analyzed for full ECMC Table 915-1 contaminants of concern. The results of the remedial excavation will be submitted on a subsequent Form 27. The remedial excavation and background soil sampling will be completed in accordance with the attached proposed soil boring map, and proposed sampling plan outlined in the Site Investigation Report of this Form 27.

The implementation schedule has been changed due to the decommissioning of the Vega USX A03-05 tank battery and necessity for supplemental site investigation and remedial excavation activities at the tank battery. The proposed remedial excavation will be completed following the approval of this form. The ECMC will be updated on a subsequent Form 27 with the results of the supplemental site investigation and remedial excavation, or if the schedule is changed due to site access constraints. The supplemental site investigation is tentatively scheduled for July 22, 2025.

OPERATOR COMMENT

This Form 27 is being submitted as a Second Quarter 2025 timeline update for the completion of a supplemental site investigation and the remedial excavation at the Vega USX A03-05 tank battery.

The 1-methylnaphthalene exceedance observed at sample location PWV01-B@6' will be removed through remedial excavation. The remedial excavation will be completed in accordance with the Remedial Action Plan section of this Form 27 and previously approved by the ECMC under Supplemental Form 27 #403965948.

Background samples will be collected to determine if pH and arsenic are attributed to native soil conditions. Proposed background soil sample locations are shown on the attached proposed soil boring map previously approved by the ECMC under Supplemental Form 27 # 403965948. The supplemental site investigation to collect background samples is tentatively scheduled for July 22, 2025.

Quarterly reporting will be conducted until closure criteria are achieved for the remediation project. The ECMC will be updated with the results of the remedial excavation and concurrent background soil sampling on a subsequent Form 27.
