It was observed in this inspection that the Location appears to have met ECMC 1004.c.(2) uniform vegetative cover requirements.

However, the O&G access road leading to the Location has not been reclaimed in accordance with 1004 requirements; including, but not limited to, compaction alleviation, recontouring/regrading and revegetation activities. Pursuant to Plan doc. #402855940 submitted by Operator with the Form 4 Final Reclamation notice, "SG will reclaim the short access road (est. 600' in length) at the same time, and to the same standards, as the well pad surface".

Corrective Action: **Comply with 1004 Rules.**
