INITIAL ACTION SUMMARY

A site investigation was conducted pursuant to ECMC Rule 911 at the GUTTERSEN ST T4N-R63W-S32 L01 Facility and Tank Battery location.

PROPOSED SAMPLING PLAN

Grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), at the risers for the flowline (s) and dumpline(s) of any separator(s). In addition, the on-site dump lines located between the separator and tank battery were removed by pulling from either end. Soil samples were analyzed by a certified laboratory for the full extent of Table 915-1, including but not limited to: TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per ECMC Table 915-1, and EC, SAR, pH, metals, and boron. All samples collected were analyzed by a certified laboratory using approved ECMC laboratory analysis methods.

Visual inspection at the tank battery area occurred during abandonment activities. Field personnel field screened all disturbed areas using visual and olfactory senses. Additionally, discrete soil samples were collected from the base of the excavation and excavation sidewall in areas most likely to be impacted and exhibiting the highest field screened VOC concentration. Remedial excavation confirmation soil samples will be collected and analyzed for full ECMC Table 915-1 constituents. A supplemental site investigation (SSI) will be completed to vertically and horizontally delineate the pH exceedances observed at sample locations AST01 @0-6" and PWV01-B@3' during decommissioning, in accordance with the attached proposed site investigation map, and proposed sampling plan outlined in the Site Investigation Report section of this Form 27.
