While conducting facility decommissioning activities at the Webber24, 9 Edington Lillvand production facility, historically impacted soil was discovered beneath the former produced water tank. The volume of the release is unknown. Assessment activities are ongoing. The historically impacted soil will be removed and disposed of and confirmation soil samples will be collected in compliance with ECMC Table 915-1. Additionally, a waste characterization sample of the impacted material has been collected and submitted for analysis of full ECMC Table 915-1 constituents. The laboratory analytical reports are attached. The topographic Site Location Map showing the geographic setting of the release is provided as Figure 1.
