This form serves as notification for the decommissioning of the Arapahoe Unit 178 wellhead. The ground and subsurface shall be inspected for hydrocarbon impacts during equipment removal. At a minimum, soil sampling shall be conducted in the proposed locations discussed below and shown on the attached proposed soil sample location map.

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

One (1) discrete grab soil sample will be collected as shown in the proposed sample location diagram, adjacent to the capped well casing. Four (4) field screening surface soil samples be collected in each cardinal direction surrounding the wellhead and one (1) background sample will be collected from an adjacent, upgradient location. If a flow line is present, one (1) discrete grab sample will be taken at the flowline riser. The grab samples will be analyzed for full Table 915-1 listed constituents. The background sample will be analyzed for EC, SAR, pH, boron, and metals.

These areas include, but are not limited to; where Flowlines connect to the wellhead, surface equipment, risers, valves, separators or manifolds, where Flowlines bend or were repaired in the past and at joints and hammer unions. Where Flowlines connect to Flowlines or equipment of different material: and where Flowlines crossed drainages or surface water or are in contact with shallow groundwater. Operator shall conduct an environmental investigation to confirm the presence or absence of impacts adjacent to the flowline at a minimum of every 250'.
