INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

In accordance with the workplan approved via Energy & Carbon Management Commission (ECMC) Form 27 Document 402986366, site assessment activities were completed pertaining to the historical pit located in close proximity to the LILLI UNIT 3-15 plugged and abandoned wellhead. On November 22, 2022, one soil boring was advanced to refusal at approximately 9.5 feet below ground surface (bgs). Four soil samples were collected for field screening at regular intervals. The soil sample from the interval with the highest photoionization detector (PID) reading (SB-01 @ 5-7.5') was submitted for analysis of ECMC Table 915-1 organic constituents and Soil Suitability for Reclamation (SSR) constituents. See Form 27 Document 403781461 and the associated Site Investigation Report (Document 403781484) for assessment details.

Noble is in the process of determining the extent of impacts associated with the project. Once impacts are delineated, Noble will request closure for the project based on Residential Soil Screening Levels (RSSLs) approved by ECMC via Document 403781461, or prepare a remediation plan to remove the source material within the investigation area, whichever is applicable.

On November 22, 2022, one soil boring was advanced to refusal at approximately 9.5 feet bgs. Four soil samples were collected for field screening at regular intervals. The soil sample from the interval with the highest PID reading (SB-01 @ 5-7.5') was submitted for analysis of Table 915-1 organic constituents and SSRs. Analytical results of the sample indicated a concentration of benzo(a)-pyrene above Table 915-1 RSSLs. Per documented correspondence with ECMC, a historical release was not reported following the assessment. See Form 27 Document 403781461 and the associated Site Investigation Report (Document 403781484) and correspondence (Document 403781492) for details.
