Technical Detail/Comments:

Venting health and safety precautions were taken to avoid nuisance and or hazards to the public.

Form 42 was submitted prior to plugging operations, Form 42 Doc #404152321. Form 42 was submitted prior to MIRU for plugging operations, Form 42 Doc #404157681.

Plugging procedure was followed to meet the COA on the Form 6-NOIA.

The wellbore was static prior to placing cement plugs, which are a minimum of 100' in length for all but the surface plugs. A minimum of 25' cement plug was used for mechanical isolation. Circulation was maintained while pumping plugs.

Surface casing plug set from 750' - surface. Cement to surface confirmed prior to cut/cap. After cut prior to cap, Operator verified isolation by a 15 minute bubble test and no flow was observed.

This form 6-SRA addresses all COA's from the Form 6-NOIA.

Operator waited a sufficient amount of time to confirm all plugs achieved to the intended design. There was no pressure or fluid migration.

Plugging procedure was modified to meet the COA on the Form 6-NOIA.

The GPS data within the form has been updated to reflect as-drilled well location.

Operator used secondary containment for all tanks and other liquid containment.
