While conducting wellhead plugging and abandonment activities at the Miller 7-10 wellhead, historically impacted soil was discovered at the wellhead riser. The volume of the release is unknown. Assessment activities are ongoing. The historically impacted soil will be removed and disposed of and confirmation soil samples will be collected in compliance with ECMC Table 915-1. Additionally, a waste characterization sample of the impacted material has been collected and submitted for analysis of full ECMC Table 915-1 constituents. Analytical results will be provided in a subsequent report. The topographic Site Location Map showing the geographic setting of the release is provided in Figure 1.
