Per Analytical data provided in Form 27 Document # 404113480 additional information is needed for soil suitability thresholds for available boron based on hot water soluble (or DPTA/sorbitol) extraction followed by analysis.

In addition, analytical data for chromium appears to be for total chromium. Per Table 915-1 Analytical Data is required for chromium (VI).

The Operator shall continue quarterly reporting until Full Table 915-1 standards are met within the remediation area.
